IQALUNGNI, Nunavut (Qiqaiyarvia 7, 2017) – Qulliq Auladjutikhanut Kuapuraissingat (QEC) uuktuqtut Ministamut havaaqaqtumut QEC-kunnun nuttamik Urhuqyuat Akiitnik (FSR mik taivagaat) utirutikhaanik 8.23 siansnik atauhirmun kilowatt mik atauhirmi ikaangnirmi. Tamna tukhiqtauhimayut utiqtitiniq manikhat aulaniaqtumik talvuuna Qitiqauyaqvia 1, 2017 hamunga Apitilirvik 30, 2017.

“Una hittamauyuq pidjutihimmaagutauyuq urhuqyuat akiitnut utirutikhainnik QEC kut piumayut talvangaTarium Hikutirvia 2015. Nigiuktun’ngalu uqaqvigiumaplugit Igluit Auladjutikhainnut Akittuutilanggitnik Ihivriuqpagait Katimayiitkut taffuma mikhaatigut QEC kut uuktuutaannik”, uqaqtuq Nan’ngariayuq Johnny Mike, Minista havaaqaqtuq QEC-kunnut.

QEC’s aulayuituq FSR utiqtiffaarutikkut haffuminga 5.26 siansnik atauhirmun kWh aularniaqtuq talvuuna Qiqaiyarviani 31, 2017. Tamaita akiliqtuivaktut piniaqtut utirutikhamik taapkualuanggittut igluqaqtuq igluliqiiyinit akiliqtuidjutuvangmatta User Pay Piutaannit.
