This is an exciting opportunity for a subject matter expert and innovative best practices leader in all health, safety and environment (HS&E) matters to drive an organizational culture of legislative compliance and ethical practices and operations - internally and throughout the communities we serve across Nunavut.

Reporting to the Director of Health, Safety, Environment and Facilities (HSE&F), you will build and promote a strong culture of safety compliance and ensure safety awareness at all levels of the organization by developing, implementing and maintaining effective safety standards, systems and tools, while continuously developing innovative systems and solutions to meet organizational needs. As Manager of HS&E, you will also coordinate annual site inspections in each community in Nunavut plus emergency response efforts, report incidents to the authorities, and develop training, reassess procedures and lead planning and action to mitigate risk, financial and image loss, and potential of recurring incidents.

DUTIES AND RESPONSIBILITIES INCLUDE:

- Reviewing applicable federal, territorial and local laws, regulations and codes, providing direction to management and staff in their interpretation and application, and ensuring company-wide compliance;
- Maintaining Certificate of Recognition (COR) accreditation;
- Providing leadership, guidance and coaching to the Health & Safety Specialist on matters related to injured worker investigations, claims, modified duties and graduated return to work;
- Overseeing the Joint Occupational Health & Safety Committee (JOHSC);
- Addressing daily issues and inquiries from Plant Superintendents regarding operational activities;
- Liaising with local Health & Safety organizations and government bodies to monitor best practices for consideration by QEC as part of our continuous improvement commitment;
- Partnering with the Environmental Specialist on waste removal, site assessments, plant and tank farm decommissioning, site delineations and cleanups, risk assessments, annual soil sampling, capital projects, etc., and developing RFPs for environmental-related services;
- Working with local Government of Nunavut entities and municipalities to develop emergency responses to environmental contamination;
- Coordinating Nunavut Impact Review Board approvals process for projects such as new power plants, fuel tank construction, new pipelines and land farms;
- Overseeing the WSCC claims management and appeals process;
- Acting as the voice of QEC on HS&E matters, by presenting to communities, participating in forums, conferences and industry seminars, and liaising with regulatory professional bodies;
- Drafting public notices and compiling Ministerial briefing notes on HS&E issues;

- Overseeing O&M budget, JOHSC training and travel budget, and annual training for plants; and
- Developing, mentoring and managing a results-oriented team focused on delivering excellent service.

REQUIRED QUALIFICATIONS INCLUDE:

- Bachelor's degree in Environmental Health, Safety Engineering, Occupational Health, Environmental Sciences, or a related discipline;
- Five (5) years of experience in organizing and managing health, safety and environmental programs, preferably in the utilities or construction industries, including two (2) years supervising staff and contractors;
- Canadian Registered Safety Professional, Environmental Professional or similar designation;
- Expert knowledge of relevant occupational HS&E legislation and emergency response coordination;
- Experience in developing and delivering safety training;
- Excellent verbal and written communication, problem-solving, analytical and presentation skills;
- Ability to establish and maintain professional relationships, negotiate and influence; and
- Knowledge of computerized systems and software, with an emphasis on MS Office suite (Excel, Word, PowerPoint).

A combination of education and related work experience may be considered.

ASSETS:

- Knowledge of Nunavut, the land, language and culture; and
- Ability to speak Inuktitut and/or French.
