Reporting to the Manager, Policy & Planning, and working closely with the Policy team, you will provide essential services in the development and coordination of QEC's strategic planning, policies and procedures, and related research. This is an opportunity to provide input into decision-making and make informed recommendations based on your own analysis and current issues, trends and political priorities.

### DUTIES AND RESPONSIBILITIES INCLUDE:

- Monitoring and critiquing political, social, economic and demographic developments affecting QEC, including the expressed positions of federal, territorial and community governments, Inuit organizations and other stakeholders;
- Analyzing research papers, studies, proposals, Legislative Assembly debates, federal agency discussion papers, correspondence, etc., to determine their corporate and fiscal effect on QEC policy;
- Prioritizing research needs, coordinating the development and implementation of research work-plans and evaluating the final product;
- Recommending strategies to ensure consistency and compliance with government-wide policies, directives and guidelines, including Access to Information and Official Languages;
- Coordinating projects and studies, from researching, summarizing and analyzing existing policies, programs and regulations, and identifying knowledge gaps and potential areas for research, to developing terms of reference and methodologies, and implementing research projects; and
- Analyzing research data, preparing reports, and communicating findings and recommendations.

### REQUIRED QUALIFICATIONS INCLUDE:

- A degree from a recognized university in Political Science, Public Relations, Communications, Public or Business Administration, or a related field, and 2+ years' policy-related experience (in at least two of the following areas: policy research and development, program analysis, market analysis, strategic planning, media relations, communications, and public relations), or an equivalent combination of education and experience;
- Knowledge of the review, implementation and administration of policies, guidelines, programs and procedures, as well as government administration procedures, and the legislative process;
- Ability to provide analyses and recommendations on complex situations with changing political and economic factors;
- Experience working in a policy, market analysis, project management, or coordinating role with an agency, board or Crown Corporation (a definite asset);
- The ability to speak Inuktitut, Inuinnaqtun and/or French (an asset); and
- Knowledge of Nunavut, the land, language and culture (an asset).

We offer a starting salary of \$82,173 per annum and a comprehensive benefits package, including a Northern Living Allowance of \$15,016 per annum. This position is not included in the Nunavut Employees Union. Subsidized staff housing is available.
